

#### **Introductions**

#### Steering Committee changes since last meeting

- Last call for executive committee nominations
  - No nominations for our third committee member (NGO cooperator)
  - Kent Van Horn Recommends we hold off until the Ruffed Grouse Society finalizes hiring of the new regional biologist
    - Dan Anderson local chapter President of the Eagle River Ruffed Grouse Society may be an option for RGS rep, but that needs to be discussed internally of RGS

#### MOU – any recent additions

- Wisconsin Center for Wildlife: Scott Hygnstrom rep in progress
  - Scott was unable to attend meeting, but work is still being done to become a partner
- Jamie Nack mentioned potential interest from UW Extension and/or Dept. of Forestry & Wildlife Ecology

#### WYFP updates – Holtz

- USFWS Webless Grant was extended till Dec. 2018
  - Fortunate to extend grant to meet all deliverables
  - Close on overall deliverables but were way under on the money spent
    - Grant will provide time for us to generate match for LTE support and Coordinator position
- RGS and WMI potential on multi state RCPP
  - NRCS Awaiting the passing of the next Farm Bill
    - It is unknown on what the new Farm Bill will produce regarding a RCPP or something similar
  - o ABC/NRCS will re-apply but will be short window once Farm Bill passes
  - Dan/Jeremy executive committee in addition to others to come up with skeleton/plan to apply – put together framework and proposal that looks similar to an RCPP application – Minimally, what deliverables and objectives should we be thinking about prior to the passing of the Farm Bill
    - What are the RCPP and others looking for project types what can we contribute to be competitive
    - Use of core group to drive the application (NGO core group) focusing on the goals and practice of the WYFP – match from the group does not necessarily have to be monetary but could be time or resources

#### **Coordinator Report - Wlodek**

- Website updates
  - Added 'For Landowners' tab tailored to private landowners filled with resources, promotional videos, testimonials, information, and activities (Family Fun) they can use for their land
    - 'Family Fun' subtab include scavenger hunts, ID guides, survey techniques
  - Added 'Monitoring' tab to show research projects WYFP is conducting in young forest management areas and to show landowners how important monitoring wildlife is
    - 'Monitor your Property' subtab discussing new iNaturalist project Wisconsin's Young Forest – an aid to landowners to observe, record, and monitor wildlife on their property
    - 'Identification Resources' subtab consisting of website links for landowners who need help with resources to ID plants/wildlife
  - May shut down WYFP webpage maintained by DNR or just have a hotlink to the main WYFP webpage
  - Randee reach out to each entity to see who is promoting WYFP webpage with a link –

- what is the cost behind entities adding success stories or promotional pages within their website
- WYFP webpage is hosted by DJ case and edited by WMI (Chuck Fergus) and payed for by WMI – Funding is unreliable and grant is running low, communication is needed between WMI and Partnership about funding – should we dedicate funds for webpage maintenance and editing
  - Options to discuss with WMI
    - bypass WMI and pay DJ case to maintain webpage
    - WMI is an official partner, and if they would like to continue to be involved, find a way to maintain a funding source and get them money
- Proposal by Jeremy Holtz Create WYFP Facebook page that mimics the official WYFP webpage – Managed by Randee with supporting partners as administrators
  - Run with this through the Outreach sub-committee to create a protocol to manage a
     Facebook page who responds who posts who monitors public comments how
     often do we post what is our identity and goals
- Outreach committee will discuss creating an email distribution list of landowners. Landowners added will get information about upcoming events, new project potentials, updates on research going on in the area, etc.
- iNaturalist workshop
  - June 16<sup>th</sup> invited landowners that have or will have young forest management done.
     Agenda can be found in Appendix A.
  - Interactive workshop to show landowners how to use iNaturalist, observe and ID wildlife, techniques behind surveying and monitoring, young forest habitat diversity (not just aspen/alder)
  - Initially targeting landowners that have worked with the Partnership to kickoff and promote the iNaturalist workshop, but in the future, we would like to have more workshops and get more landowners involved that are not just WYFP clients
  - Advertise June 16<sup>th</sup> workshop on DNR Facebook page with testimonial, WYFP introduction, and advertise workshop series we are starting – Kent VanHorn and Randee Wlodek
- 2017 Annual Report great reflection on what the partnership has become
  - o Finalized report will be posted to the WYFP webpage in June
  - Updated habitat impact since partnership birth and over the course of 2017, as well as,
     the number of management plans created or updated with partners work and outreach
  - Needs moving forward
    - Right now, the Annual Report is geared towards our partners to update them on what the partnership is doing and this will always be a priority to update the

partnership

- In the future may add some tidbits that are more geared towards our private landowner clients to provide them with what has been to show what they are a part of as a participant
- Do we need to include total dollar amounts spent on these different projects grant dollars generated match dollars generated??
  - Decided partners can report that in house to their committees to show what was done and what they chipped in individually

#### **Subcommittee Reports**

- Personnel Holtz
  - Nora Kennedy ABC left position, but position is posted for applications (Callie sent out link in email)
  - Potential intern through Scott Hygnstrom and the Wisconsin Center for Wildlife (Scott looking to be involved and exposed to young forest and habitat management)
  - RGS future regional biologist will have a high priority to work directly with northern Great Lakes staff to expand habitat work area.
- Outreach Wlodek
  - Cold contact mailing results 2000 letters mailed out end of April/early May
    - Price County and small portion of Oneida County
    - 33 responses to date (5/30/18)
      - 5,178 acres are represented with the 33 responses
      - 3,000 of those acres do not have management plan
    - Landowners that have been contacted before and responded (since 2012) have been removed from the mailing
    - Cold contact mailing has been successful for the Partnership and should continue in the future – additional outreach (social media) is welcome
    - Two letter processes second letter will be sent out in the fall to the nonrespondents from the first mailing
    - Suggestion to add something in letter to tell already engaged landowners to contact us and let us know they don't need help or to encourage them to contact us in case there are additional programs/practices they may be eligible for (CSP)
- Funding/fund administration Eklund
  - NRCS For the Lumberjack RC&D Committed to and ready to go with \$25,000/year for three years – on quarterly basis – provides housing, logistical, and supervisory support to the contracted coordinator position to relieve others in the partnership – will add

another \$1,000/year for website for three years to total \$26,000/year

- Set meeting (phone/skype/in-person) with NRCS and DNR forestry and wildlife to discuss logistics behind managing the finances behind the coordinator position (include Eric Ulness from NRCS)
  - NRCS and DNR will have separate agreements with Lumberjack
  - Federal fiscal year vs state fiscal year
  - Plan work schedule on when deliverables are due to meet objectives that partners are paying for
- Guidelines/expectations of coordinator position from NRCS
  - Coordinate/facilitate stakeholder meetings
  - Young forest outreach event coordination and participation
  - Develop young forest habitat promotional material
  - Coordinate and conduct young forest outreach mailings and generate EQIP application submissions
- Figure out Farm Bill and RCPP outcome
- SFI grant useful to us to get landowners management plans, print brochures, info packets, etc. (usually between \$1,000 to \$2,500 to keep us on their radar and them on our radar)
- Something to think about: As we expand territory we can be expanding our community with who we communicate with adding more groups with different habitats (jack pine, Kirkland's warbler, and other species across the state to include different types of young forest habitat) feedback from sub-committees on thoughts about the workload that including other species and habitats would have on the partnership
- O When will RGS initiate their Drummer Grant Timeframe?
  - Start putting proposal together now in preparation for the application process that will be coming up eventually
- Monitoring/research Buckardt
  - Anna was unable to attend, but is working on her analysis of the geolocators and will be able to share more once results are published. See Appendix B for update.

#### Partner updates - each rep fills us in

- USFS Dan Eklund Work on funding and transitioning to Lumberjack
  - On the ground wood is getting cut primarily aspen with some black ash
- NRCS Chris Borden
  - Conservation stewardship program talk more about the CSP opportunities because things have changed and will most likely continue to be available through the next Farm

- Bill **Add time in agenda during next meeting** or have separate meeting with on the ground staff to talk about additional opportunities. Potentially use a field trip type setting in an area that needs work to use as an example.
- Impact the partnership through providing information on habitat type correlation through soil mapping/soil surveys in relation to forest type
  - Soils suited to blueberry, white cedar, and hemlock based on soil map unit/Kotar etal. Forest community and habitat type correlation

#### - USFWS - Kurt Waterstradt

- Waiting on RGS to hire regional biologist to reengage with them as a partner and renew FY16 agreement, since it is starting to run low, in order to set aside funds for young forest habitat work.
- Across the north in our 21 core counties, looking to complete about 9 12 projects for the year 2018 potentially spending between \$15,000 and \$20,000. Budget for 2018 is stable but may get cut going into 2019.

#### - DNR - Wildlife - Kent Van Horn

- Statewide prioritization of habitat type management for staff time with re-organization of the Wildlife Management structure. State lands were then prioritized into 1, 2, or 3 to direct our work and resources once habitat types on these state lands are mapped.
- With alignment on the tail end of completion, the agency is in the process of filling
  positions across the state to fill openings within the wildlife program to have more staff
  to support the WYFP goals and objectives.
- Million dollars a year set aside to interested parties to grant out for habitat work and increase public access. In search of non-traditional partners to get involved and partner up with the DNR. This is in hopes to increase management on private lands.
- Hunter types and land bases used License sales that are increasing are using private land and the license sales that are stable or decreasing are using state public land.
   Looking more into statistics like these show us where we should be putting our efforts and resources.
- Ruffed Grouse Update Grouse population numbers follow a long-term cycle. West Nile virus Pennsylvania found in poor habitat, occurrences of west Nile virus increased, but in areas that have good habitat west Nile virus does not seem to impact grouse at the population level. Michigan tested some birds in hearing these results and found west Nile virus within ruffed grouse. Wisconsin folks are worried this is what is causing the low numbers in our grouse population. There is no evidence that west Nile is in our grouse population yet... but in result of all of this it was suggested that the DNR should decrease the length and bag limit of ruffed grouse during the 2018 fall season.
- Missouri have asked for ruffed grouse to be translocated. They will receive 300 over the next three years at 100 birds/year.

- DNR Wildlife Janet Brehm
  - Starting to do site visits on private property for alder/aspen management
  - Tom Carlson has fully transition into new technician position in Wausau
  - Eric Borchert in Langlade county was able to finish up an additional 25 acres with the late winter
  - MFL forester found property on with nice upland alder to shear
  - Lincoln county and city forests have alder shearing projects set up, from Tom Carlson.
- DNR Forestry Kristin Lambert & Diane Anderson
  - o Have been in the process hiring new class of foresters for the northern area
  - Private land forestry Wisconsin Private Forest Advisory Committee made up of partners reporting to state forester. 1-million-acre goal to reach unengaged woodland landowners across the state (model can be found in Appendix C; Kristin Lambert also sent email with detailed information). Million-acre goal is focused to get landowners engaged through workshops, field days, conferences, have a forester walk through a property, and become a member in an organization. Strategy is in place to promote the Wisconsin Private Forest Advisory Committee goals and objectives. In the future the goal is to have a collaborative effort in reaching out to unengaged landowners.
  - DNR is partnering with Aldo Leopold Foundation, NRCS, NWTF, and others to conduct an oak restoration workshop geared towards to deer, turkey, and small game. Three-tiered program for rookie to veteran land managers
- WCFA Eric Holm and Gary Zimmer
  - It was a good winter for cutting across the county. Nearly reached annual acre goal for the year
  - WCFA 'Plan your grouse hunt' brochure (downloadable on website) is completed and out to promote county forest land that is managed for grouse. Also have online map up to date and running to show hunters where they are within the county forests.
- ABC Callie Bertsch
  - Last season was great for getting work done on the ground 99 RCPP contracts completed.
  - ABC position is now posted GIS and Forestry experience (Nora Kennedy's old position)
  - RCPP will be competitive between Minnesota, Wisconsin, and Michigan which completed the amount of work this past season across the three states
  - Grants still working with NFWF grant that ends 2018
    - Public land habitat management has about \$30,000 across the three states to get work done before the end of 2018 – specific to young forest management for woodcock and golden winged warblers

- Outreach money is available for workshops and trainings for landowners and contractors
- Thinking about other species and habitat to include in the RCPP application
- RGS Jared Elm (Ladysmith) and Dan Hoff (Lena)
  - On second round of regional biologist interviews covers Wisconsin, Minnesota, Iowa,
     Illinois
  - CSP and EQIP has been the primary workload how can we help landowners that have already been doing work on their land.
- WWF Bob Ellingson
  - Annual meeting will happen in two weeks June 16, 2018
  - Will be pushing for getting the Farm Bill passed and getting it moved up on the priority list and advocate for the WYFP and its importance
- NRCS Katie Koch
  - Northern Forest Bird Workgroup Meeting in Ashland, WI was successful to create and organize a workgroup for BCR 12. Creating a list of priority species and habitat that the workgroup should be focused on, mainly ones that nest in our BCR 12 region. Provides a communication avenue for the different groups and agencies to keep track of grants and updates going on in our area.
  - Breading Bird Atlas and data recording could we add iNaturalist bird observation to eBird
  - Young Birders Organization will have a workshop/camp in lower Michigan to promote the next generation of birders and bird conservation.
  - Forest Stewards Guild workshop is sponsoring an event on forest management for birds (Peter Gieser) June 22<sup>nd</sup>. This is the next step to forest management to piggy back off the norther forest bird workgroup meeting.

Partnership needs, partner needs & opportunities for involvement; future steps, plans for expansion/subsistence; big picture discussion

- Next meeting will be set in the fall – be on the lookout for doodle pole for dates

UMaine Research Update for WYFP Steering Committee -May 2018



As you may remember, Anna deployed 28 geolocators on Male Golden-winged Warblers in Oneida County in the Spring of 2016. The geolocators are archival tags that measure and record light levels every two minutes for a year to track migration and wintering. In order to receive data from the tags, the birds must be manually relocated and recaptured the year following geolocator deployment. Once the tags are recovered, the light level data is used to determine the sunrise and sunset times, and day length of each day. Through programming and calculations in program R, this can then be extrapolated into an approximate longitude and latitude of the location of the bird throughout the year.

Seven of these tags were recovered in 2017 and data analysis and processing is underway. So far, Oneida County Golden-wings are traveling south across the Gulf of Mexico and spending the winter in Central America between Honduras and Panama. Analysis of geolocator data has a steep learning curve, but Anna has analyzed 16 geolocators to date including many deployed by collaborators in Vermont, New York, and Michigan. She will continue this analysis with intent to publish findings. Although she and her advisor Amber Roth are excited by the results, they will be keeping specific findings confidential until publications have been accepted. They appreciate your understanding and would be happy to answer any questions about the process through email. Anna will be back in Oneida County this June in search of 11 geolocators that were deployed in 2017. She will also be helping to host the landowner iNaturalist Workshop that Randee will be talking about.

## ACQUISTION

Gaining new contacts interested in forestry that represent constituency and potential for action.

### Who is?

- Exciting landowner interest
- Cataloging contacts

Example: 5,600 new NIPF landowners requesting information, based on 20% response rate

## CULTIVATION

Social and professional interactions that build a landowner's self-efficacy and commitment to action.

### Who is?

- Conducting forester walk-throughs, identifying doable practices, following-up
- Converting new contacts at conference and field day attendees to walk-throughs Example: 3,000 new NIPF landowner walk throughs totaling 150,000 acres/yr., based on 5% response rate

# MPLEMENTATION

Services necessary for landowner to complete action.

### Who is?

- Prompting financial assistance sign-ups
- Prompting recommended practices in plans Examples: 360 new NIPF landowners entering costshare annually; 1,000's of NIPF landowners conduct a timber sale within 10 years of initial engagement

EVALUATION AND TRACKING: Who is? Identifying new landowners, developing and tracking metrics, and collecting and sharing information with stakeholders
